### 1. Queen Elizabeth 11's Jubilee Celebrations

James Easter reported the following:

- 5.6.22 Village Hall open [Big Lunch]

South Norfolk online treasure trail plus prize

The South Norfolk Council suggest Bridge at Lodden be repaired and renamed 'Queen's Jubilee bridge'

As part of the Queen's Green Canopy scheme **JE** may be able to acquire trees for the village. But all trees planted this year should be logged on SN council tree scheme website.

**PR** Pegg's Green could have trees planted there.

P C Committee discussed lighting of the beacon, the Piper, floodlighting at the allotments. **MH** offered the use of her generator.

There was some concern raised over the allotment polytunnels. **MH** stated that the beacon was there before the polytunnels.

LE to contact Mervyn Lambert about availability of other lighting as well as:-

Fire safety Advisory Board, Chair of VH re bar opening on 2.6.22 and Carl Taylor [who has already been contacted to assist.] Check Zurich Insurance and Allottments re Public liability insurance. National Anthem music to be played.

Residents to be informed about the village events online and leafleted to ask for volunteer Marshalls en-route to the allotments for Beacon lighting. **SG** would like a volunteer meeting in March.

**SG** to prepare a plan to accompany the PC's South Norfolk £200 Grant application **JE** to take responsibility for the evening's events as **SG** will be elsewhere.

#### 2. B-H-A Flood Survey

Survey to cost £1300 plus VAT. Proposed **MH** 2nded by **PC**. **LE** stated Mark Butler has not responded about ownerships of villages ditches as requested.

#### AOB:

30 mph Traffic calming sign on B1077 currently outside 'The Cottage' Winfarthing Road, Shelfanger has been reported by local resident as being ill placed.

LE to contact Highways for more information on possible relocation of this sign.

Mrs Pam Ross said that Anglia Water did attend to water leak in Common Road after it was reported by the Clerk last month.

**SG** met Diocese representative re dead Chestnut tree in Church Walk.

County Broadband continue to survey the village for fibre internet connections.

<b>JE</b> reported that following his visit to the Bressingham AD plant he noted that nothing there is yet operational. Richard Bacon MP recently visited the site and has sent his objection to SN planning.
